The Marshall County Revenue Commissioner desires to appoint a Deputy Revenue Commissioner pursuant to Ala. Code §40-4-6 and §40-5-2 (1975, as amended). To do so the Commissioner requested that the Marshall County Personnel Board determine a salary to for a new Deputy Revenue Commissioner position. The Commissioner represented to the Board that the Board's only involvement in the creation of the position was to set the salary for the position.

Further review of the matter leads the board to believe that pursuant to Ala. Code §40-6A-5 and §45-48-241.02 1975, as amended) the Deputy Revenue Commissioner would be a merit based employee; therefore, the creation of the position is required to follow the polices and procedures of the Board. These policies include but are not limited to, the creation of job specific qualifications and job duties, and advertisement and posting of such position, and an application process. The position would also be offered the same protections provided by the Board as all other merit based positions.
