APPROVE PROCLAMATION NAMING MAY 1, 2011 AS LAW DAY

A motion was made by Commissioner Stricklend, duly seconded by Commissioner Maze and so carried to approve the proclamation naming May 1, 2011 as Law Day.

WHEREAS May 1, 2011, has been designated as Law Day in the United States of America and the State of Alabama; and

WHEREAS, this year's national Law Day theme is "The Legacy of John Adams: from Boston to Guantanamo," which reaffirms the principles upon which our great nation was founded. This theme emphasizes proper adherence to the rule of law, even in the face of challenging circumstances. As Americans, we continue to preserve these principles through our lawmaking and judicial systems; and

WHEREAS, it is the ideal of an understandable, fair playing field (truly, "justice for all") that has guided our government in making and enforcing our laws. Our lives are touched by the rule of law on a daily basis, whether at home, work or school. Each time we recite the Pledge of Allegiance, we renew our commitment to obtaining equal justice for all under the law; and

WHEREAS, the fact that we continue to strive to be one Nation, under God, with liberty and justice for all, is a tribute to the memory of the millions of Americans who, throughout our history, have been willing to die to secure or preserve these ideals; and

WHEREAS Law Day is an important opportunity for all Americans to improve their understanding and appreciation of the contribution law makes to the preservation of liberty and justice. We urge all citizens to join with us in renewing our dedication to those principles for which so many Americans have sacrificed their lives.

NOW, THEREFORE, We, the County Commission of Marshall County, Alabama, do hereby proclaim May 1, 2011, as Law Day.
