# APPROVE COUNTY ATTORNEY TO SUBMIT INQUIRY TO ACCA AND ALL COUNTIES IN ALABAMA REGARDING REDISTRICTING LITIGATION AND UPON FINDINGS AUTHORIZE RETENTION OF VOTING RIGHTS ATTORNEY GREG HAWLEY

A motion was made by Commissioner Maze, duly seconded by Commissioner Stricklend, with Commissioner Kilgore voting yay and Commissioner Hale voting nay, and so carried to approve county attorney, Clint Maze, to submit inquiry to ACCA and all Alabama counties regarding redistricting litigation. Upon findings of said inquiry authorize retention of voting rights attorney Greg Hawley and inquire about costs of such litigation and opinion letter.

#### DISCUSSION REGARDING REDISTRICTING LITIGATION

Commissioner Maze is in favor of the inquiry with regard to redistricting litigation, but is hesitant to spend an enormous amount of money without a secure guarantee of success. Commissioner Maze stated District 2 includes the City of Guntersville which was split in half with the redistricting. This has affected the schools by putting the high school and elementary schools in separate districts. Commissioner Hale is strongly opposed to the litigation inquiry and the filing of a lawsuit. Her opposition is due to the cost factor of same. Mrs. Hale stated filing suit would be an inconvenience for the county that will be faced with many financial inconveniences for the next few years due to the economy. Commissioner Stricklend is in favor of the inquiry and possible litigation due to the fact District 1 was seriously divided and affected by the redistricting.

#### **ANNOUNCEMENTS**

District 3 - Commissioner Kilgore announced the closing of bridge at Douglas Height Road due to test boring and possible clearing for new bridge. Also announced the District 3 shop will be closed the week of July 4<sup>th</sup>.

District 2 - Commissioner Maze announced the pavement completion of the walking trail at Grant City Park. He also announced the paving of the cross drains on Buck Island Road. Also announced the District 2 shop will be open the week of July 4<sup>th</sup> with a partial crew.

District 1 - Commissioner Stricklend announced the electronic gates at Park 2 were now completely installed and fully operational. Also announced the District 1 shop will be closed the week of July 4<sup>th</sup>.

District 4 – Commissioner Hale announced the District 4 shop will be open but with a partial crew.
