ANNOUNCE OPPOSITION TO AMENDMENT 2 ON THE NOVEMBER GENERAL BALLOT

Chairman Hutcheson announced Marshall County Commission's opposition to Amendment 2 on the November General Ballot. This is a constitutional amendment proposed by Act 2013-266, which would increase bonding authority paid from principal in the Alabama Trust Fund by \$50 million resulting in the diversion of up to \$74 million in Alabama Oil and Gas Capital Payments otherwise required to be deposited in the Alabama Trust Fund.

APPROVE REDUCTION OF REVENUE LINE FOR PROPERTY TAX ASSIGNED TO REVENUE COMMISSIONER SALARY BY \$70,979.05; BUDGET GENERAL FUND FUND BALANCE FOR SAME

A motion was made by Commissioner Martin, duly seconded by Commissioner Hale, all members voting affirmatively and so carried to approve reduction of revenue line for property tax assigned to Revenue Commissioner salary line by \$70,979.05 and budget the general fund fund balance for same. This is due to the Revenue Commissioner retiring a year ago. The funds set aside for the salary line were not used and will rollover to the general fund. This money will be moved to supplement the current Revenue Commissioner's salary.

APPROVE SELL, TRADE OR SCRAP OF FIXED ASSETS
