### 03/08/2017

The Marshall County Commission met in regular session on Wednesday, March 8, 2017 at 10:00am in the Marshall County Commission Chambers.

### PRESENT:

Chairman Hutcheson called the meeting to order and led the invocation. He then asked Commissioner Martin to lead the Pledge of Allegiance.

# CONSENT AGENDA

A motion was made by Commissioner Martin, duly seconded by Commissioner Kelley, all members voting affirmatively and so carried to approve the consent agenda as read by Chairman Hutcheson. The consent agenda includes the minutes from the February 22, 2017 commission meeting and the claims docket for February 21 - March 6, 2017 in the amount of \$474,332.80.

# DISTRICT 2 – PUBLIC HEARING TO VACATE POULTRY LANE

A Public Hearing was held. Attorney Wade Wright with Wright & Wright introduced the information. The request was made by the Burgess family, the only family that occupies Poultry Lane. County Engineer Bob Pirando confirmed there was no opposition regarding vacating Poultry Lane.

# APPROVE VACATING POULTRY LANE

A motion was made by Commissioner Martin, duly seconded by Commissioner Kelley, all members voting affirmatively and so carried to approve adopting the resolution as read by the County Attorney to vacate Poultry Lane.

# <u>SHERIFF – APPROVE FUNDING FOR ELEVATOR REPAIR OF \$2,857 FROM COURTHOUSE AND</u> JAIL FUND

A motion was made by Commissioner Stricklend, duly seconded by Commissioner Martin, all members voting affirmatively and so carried to approve funding for elevator repair of \$2,857 from Courthouse and Jail Fund.

# APPROVE C & D LANDFILL APPLICATION

On March 06, 2017 Tommy Gamble hand delivered a letter to Marshall County Commission requesting to withdraw his application to re-open Marshall C & D Land Fill. A public hearing was scheduled for that same day. Marshall County Commission continued with the Public Hearing as scheduled. During the regularly scheduled work session the Commission decided to proceed with the application that had been submitted by Mr. Gamble. This decision was based on the facts, public concern, and pending litigation surrounding the landfill. A motion was made by Commissioner Kelley, duly seconded by Commissioner Swords, all members voting affirmatively and so carried to reject the application submitted by Tommy Gamble to re-open Marshall C & D Landfill. Chairman Hutcheson opened the floor for discussion. Commissioner Kelley discussed he would commit himself to follow up with the District Attorney and Alabama Department Environmental Management on permanently closing the landfill properly. Chairman Hutcheson agreed with Commissioner Kelley that steps needed to be taken to properly close the landfill and he would do whatever he could to assist Commissioner Kelley.

County Attorney Clint Maze recommended the Commission pass a resolution at the next scheduled meeting, spelling out the facts learned at the public hearing. He also suggested calling on ADEM to reactivate the litigation from 2006 and properly close the landfill.

# APPROVE APPOINTMENT OF DR. HANNAH NIXON TO THE MOUNTAIN LAKES BEHAVIORAL HEALTHCARE BOARD FOR NEXT TERM

A motion was made by Commissioner Stricklend, duly seconded by Commissioner Martin, all members voting affirmatively and so carried to re-appoint Dr. Hannah Nixon to the Mountain Lakes Behavioral Healthcare Board from April 2017 – April 2023.

# APPROVE APPOINTMENT TO THE MARSHALL JACKSON MENTAL RETARDATION AUTHORITY BOARD

A motion was made by Commissioner Kelley, duly seconded by Commissioner Stricklend, all members voting affirmatively and so carried to appoint Patricia Moore to the Marshall Jackson Mental Retardation Authority Board. Patricia Moore is completing Nita Chastain's appointment which will expire October 2021. Ms. Chastain resigned February 2017.

A motion was made by Commissioner Kelley, duly seconded by Commissioner Swords, all members voting affirmatively and so carried to re-appoint Ben Jones to the Douglas Water Board.
