### **CONSENT AGENDA**

Commissioner Kelley requested a modification to the minutes provided to the Commission. County Attorney Clint Maze announced the first change requested was on the re-appointment to the Douglas Water Board. The minutes reflected Ben Jones, but the approved applicant was Ben Gore. Commissioner Kelley also requested an insert under the section of the minutes "Approve C & D Landfill." Attorney Maze read the insert to the Commission. A motion was made by Commissioner Stricklend, duly seconded by Commissioner Kelley, all members voting affirmatively and so carried to approve the consent agenda with the above mentioned and stated amendments to the minutes as read by County Attorney. The consent agenda includes the minutes from the March 8, 2017 commission meeting and the claims docket for March 6, 2017 - March 20, 2017 in the amount of \$727,196.32.

## DISTRICT 1 – APPROVE PLEASANT VALLEY BAPTIST CHURCH CEMETERY

# APPROVE FRANCHISE AGREEMENT WITH NORTH ALABAMA ELECTRIC COOPERATIVE

This agreement is for 20 years and includes a fee of 3% of gross subscriber revenue.

# RESOLUTION OF THE MARSHALL COUNTY COMMISSION

WHEREAS, Marshall County, Alabama is a political subdivision of the State of Alabama; and

WHEREAS, within the limits of Marshall County, Alabama, located on the Pleasant Grove Road, Section 5, Township 9 South, Range 3 East, lies real property previously used as Bishop Landfill; and

WHEREAS, the previous owner of the subject real property was Bishop Landfill, Inc and the current owner of the subject real property is Marshall C&D, LLC; and

WHEREAS, the Alabama Department of Environmental Management, in 2005, Marshall County Case Number CV05-200187, filed suit against Bishop Landfill, Inc and Philip Bishop; and

WHEREAS, in an order dated November 22, 2006, the Marshall County Circuit Court found that Bishop Landfill, Inc and Philip Bishop were in violation of ADEM regulations and that, as a result of such violations, the landfill constituted a nuisance *per se*; and

WHEREAS, the ADEM regulation violations on the subject property continue to the present creating, among other things, upon information and belief, water pollution in Lake Guntersville, odor pollution, unsanitary conditions and unsightly conditions at and around the subject real property.

NOW THEREFORE be it resolved that the Marshall County Commission hereby request that the Alabama Department of Environmental Management reopen its investigation into the violations at the subject property and continue its action against the owner of the landfill enforce ADEM regulations at the subject real property.
